Also the deduction for Organizing for Preapprentices is \$.20, but there is no vacation deduction.

*** The Labor Agreement provides for a paid Labor Day holiday which equates to approximately \$.20 per hour for Journeymen. Therefore, the Journeyman total package cost should be increased by \$.20 per hour to determine the true total package cost per hour. See Article V, Section 3 of the Labor Agreement for further explanation.

The current IRS mileage rate is \$.535 per mile.

Effective 5-1-2018, there will be a total package increase of \$2.60 per hour and on 5-1-2019, there will be a total package increase of \$2.60 per hour. On both of those dates, the Foreman and General Foreman will each increase an additional \$.50 per hour.

The Contract expires April 30, 2020.
