^{*}The Taxable Base pay rate includes the Vacation Fund deduction of \$1.79 per hour and the Organizing Fund deduction of \$.68 per hour for a total deduction of \$2.47 for Journeymen. For apprentices, the Organizing Fund deduction is \$.68 per hour and there is no Vacation deduction.

The SASMI contribution rate for Foremen is the same rate as for Journeymen. All SASMI contributions are paid at the straight time rate, including work hours paid at the overtime pay rates.

The base wage for Apprentices with Single Coverage is calculated by multiplying the applicable percentage rate by the Journeyman (Plan A Family) base rate and adding \$3.32. The base wage for Apprentices with Family Coverage is calculated by beginning with the applicable Single Coverage rate and reducing it by the difference in cost for Single and Family coverage.

The Total Package for all Journeymen will increase \$1.55 effective June 4, 2018 and an additional \$1.65 effective June 3, 2019. The contract expires May 31, 2020.

The current IRS mileage reimbursement rate is \$.535 per mile.
